At a court in Fairfield 19 Oct 1658

Widdow Baldwin hath Attested that the Inventory of Her last husbands estate taken by goodman Knowles Anthony Wilson & John Cable that all her husbands estate is then taken according to the best of her knowledge The said Baldwin dying Intestate The Court appoints Cornelius Hull and John Baldwin and Widdow to be Administrators: they are first to pay all due debts due to any out of the estate & the Legasies to the former children And Widdow to land a third part of the rest of the estate And the remainder to be divided among the said Goodman Baldwins children as followeth: To the eldest sonn John he is to have a double Portion And to the three children he had by the said Joan Baldwin they shall have equall Portions one with another: And his three children by his former wife now living in Milford they are each of them to have half soe much as one of thos three children she had by this last husband: The said Johns Portion And The portions of thos children at Milford are to be payd to him and to those Guardians at or before the first of March next ensuing: And to be payd out for the younger children at Milford for their best advantage: And the three children she had by this last husband shall have their portions the sons at twenty one years And the daughter at eighteen years of age And yt any of the children dye before they receive their portions it shall be divided among the rest:
